BARN FULFILLS ITS EDUCATIONAL MISSION THROUGH FORMAL CLASSES, INFORMAL LEARNING OPPORTUNITIES, AND EVENTS WITH SPEAKERS. BARN OFFERED 633 CLASSES IN 2017 WITH 932 UNIQUE INDIVIDUALS ENROLLED IN CLASSES. TOTAL REGISTRATIONS WERE 4560, REFLECTING THE FACT THAT MANY INDIVIDUALS TOOK MULTIPLE CLASSES. AMONG PARTICIPANTS WHO LISTED THEIR ADDRESS, 21% WERE FROM COMMUNITIES OTHER THAN BAINBRIDGE ISLAND, HELPING TO FULFILL BARN'S GOAL OF BECOMING A REGIONAL CENTER FOR ARTISANAL EDUCATION.
